Introduction

Each year, CEU's Career Services Office (CSO) prepares and administers an annual First Destination Survey (FDS) to gather data and report on the employment situation of master's graduates roughly six months after graduation. CEU's Institutional Research Office (IRO) provides extensive support in terms of survey data analysis and reporting. This is in line with higher education best practices. It also aligns with the CSO mission of contributing to institution-wide efforts to ensure CEU graduates are prepared to transform their CEU experience into meaningful professional engagement and that the university is prepared to communicate about the impact of a CEU education.

This document contains a department-specific report based on responses of 2018 Department of Legal Studies graduates to the 2018 First Destination Survey.

Of note, this is the second year that the CSO employed a single mechanism to survey all CEU master's graduates, an outcome of the 2017 integration of CEU's former three Career Services Offices (central CEU Career Services Office, SPP Career Services Office, and Business School Career Services Office). The process this year included a thorough review and revision of the survey with input from IRO. Additionally, survey-related outreach to 2018 master's graduates involved additional steps to increase the survey response rate. Finally, and again in line with best practices in the field, this year's data-gathering and reporting process included, for the first time, additional steps to expand the overall knowledge rate. This report therefore includes data beyond the information gathered through the 2018 First Destination Survey (FDS).

Methodology


The 2018 FDS was conducted from January to April 2019. The online survey gathered details about graduates' employment status (employed, engaged in continuing studies, seeking employment) and about the experiences and challenges they faced in accessing the job market and planning for the future. CSO received a list of 553 master's graduates from the Alumni Relations Office (ARO) for the purpose of sending out personalized survey completion invitations. CSO followed up with repeat reminders, including a personalized reminder from department heads. A final email from CSO invited non-responders to complete an abridged version of the FDS or "mini-survey" that included only the most fundamental questions for outcomes reporting and yielded an additional 22 responses. Finally, in order to increase the overall knowledge rate regarding employment outcomes for 2018 master's graduates, CSO also integrated data gathered from other sources, such as information obtained by ARO colleagues, direct contact with alumni and through research on platforms such as Linkedin. Thanks to these efforts, the overall knowledge rate regarding the first career outcomes of 2018 master's graduates is 80%, while the survey response rate is 68%.


Observations

The overall CEU FDS response rate of 68% for the 2018 First Destination Survey represents a 16% jump compared to the 2017 FDS response rate of 52% (which was in line with previous CEU destination surveys). Several factors likely contributed to this increase. Starting with the 2017/18 academic year, CSO introduced dedicated career advisors or "Program Liaisons" (PLs) for all CEU master's students. PLs serve as points of contact with and career advisors to CEU master's students on specific academic programs. One hypothesis linked to the introduction of the PL model was that by encouraging students to engage with a designated professional and by developing a more personalized communications approach, engagement rates including FDS response rates would increase. The invitation from department heads to complete the survey, which was introduced this year, led to a significant boost in responses (10% increase), as did the innovation

of the mini-survey. Factoring in the overall 80% knowledge rate, the Career Services Offices is able to present fundamental employment data regarding 28% more fresh graduates than in 2017.

A note: Due to the introduction this year of information gathered via multiple sources, including the annual First Destination Survey as well as other channels, the discussion at times refers to data linked to the overall knowledge rate and at times to data gathered solely through the survey.





The FDS **response rate of 71% for LEGS graduates** reflects responses received from 41 of 58 individuals who graduated from LEGS master's programs in 2018. This is three percent higher than the overarching institutional response rate, and a 14% increase compared to the LEGS response rate from the 2017 FDS. Additionally, it was possible to collect basic information regarding another 4 graduates, resulting in an overall **knowledge rate of 78%** for the most foundational questions, including current employment status, location of employment/studies, institution/organization, and job title/academic program.



Short summary of overall results across CEU

Across CEU, 78% of 2018 master's graduates about whom CSO was able to gather first destination knowledge were employed at the time of the survey and information-gathering period. An additional 11% were enrolled in a program of further study, while 11% were unemployed. (These figures are in line with responses received via the 2017 FDS survey and previous surveys.) Among "employed" individuals, 53% are employed in business/private sector, 15% in the NGO sector, 14% in government/public sector, 12% at an educational or research institution, and 6% at an international/multilateral organization. (Within this broader institution-wide breakdown, employer sector distribution actually varies a good deal from department to department.)

59% are working in their home country, 41% in a different country.

Among employed 2018 FDS respondents, 70% report being "very satisfied" or "satisfied" with their position, and 82% report that the role is relevant to their CEU degree.



Among individuals pursuing further study, 67% are engaged in doctoral studies, while 31% are pursuing another degree at the master's level. 2% are enrolled in a certificate program.

87% of 2018 FDS respondents engaged in continuing studies are studying either a social science or humanities subject. 77% report being "very satisfied" or "satisfied" with their current course of study. 77% also report that they are "very well prepared" for this course of study thanks to their CEU experience.


